RSUs accrue quarterly dividend equivalents in the form of additional RSUs representing common stock dividends as approved by the Board, which vest on the same schedule as the underlying RSU award.
- The RSU award accrued 345 additional shares during 2021 through automatic dividend reinvestment.
- The RSU award accrued 348 additional shares during 2021 through automatic dividend reinvestment.
