- Balance includes 8 shares acquired on 03/10/2010 through the automatic dividend reinvestment feature of Exelon plans.
- Balance reflects a reduction of 11 shares that were previously reported as acquired on 05/24/2010 due to an error; the reporting person had made a contribution to another fund within the deferred compensation plan; but the administrator erroneously allocated the contribution to the Exelon stock fund.
